



How can I register to participate as a virtual shareholder at the Koninklijke DSM N.V. Virtual Meeting?



As a Koninklijke DSM N.V. shareholder/depositary receipt holder, you will first need to create a profile via <u>www.abnamro.com/evoting</u>, where you are requested to provide your mobile phone number and custody account number.

Where can I login to participate in the Virtual Meeting as a virtual shareholder?

You can participate via the ABN AMRO platform and login via www.abnamro.com/evoting

The ABN AMRO platform isn't allowing me to login, what should I do?

Can I test if I can get into the virtual environment ahead of the Virtual Meeting?



Yes, you can do so after the Close of Registration, Thursday 29 April 2021 following the guidelines on <u>www.abnamro.com/evoting</u>. Should you face difficulties, please contact ava@nl.abnamro.com or by telephone +31 (0)20 344 2000.

How do I know if my bank has approved my registration for the Virtual Meeting?



You will receive a confirmation from ABN AMRO by email. This might take a few minutes. In case the confirmation takes longer than that, please do not hesitate to contact ABN AMRO via ava@nl.abnamro.com or by telephone +31 (0)20 344 200. We advise that you already use the testing period before the day of the Virtual Meeting to test your access to the platform.

I have already registered for online participation at the Virtual Meeting, but now I would like to participate in-person or through a proxy. Is that possible?



It is not possible to participate in person. You can hand in a proxy before the Close of Registration, Thursday 29 April 2021 17:00 CET. As further specified in the convocation of the Virtual Meeting and as stated on www.abnamro.com/evoting.

As of which moment can I login to the Virtual Meeting?



You can login within a time frame of two hours before the start of the Virtual Meeting. Once you have done so you are counted as a shareholder attending the Virtual Meeting, even if you leave before the start of or any time during the Virtual Meeting (whether or not due to an internet connection failure).

How can I follow the Virtual Meeting?



You will be able to follow the meeting via webcast via www.abnamro.com/shareholdermeeting or in the virtual environment via <u>www.abnamro.com/evoting</u>.

Can I follow/participate the Virtual Meeting if I'm not a shareholder?



Yes, to follow the webcast please visit www.abnamro.com/shareholdermeeting, but you cannot vote or speak. You can also follow the webcast on dsm.com.

What do I need to do to participate at the Virtual Meeting?



You can submit your votes via proxy through ABN AMRO or attend the Virtual Meeting online, or you can register via <u>www.abnamro.com/evoting</u>.

When do I need to login when I want to attend and vote during the Virtual Meeting virtually?



You will be able to login from two hours prior to the meeting until the meeting starts. The meeting will start at 14:00 CET on 6 May 2021.

How do I know that I can vote during the Virtual Meeting?



Once the Chairman has opened the shareholder meeting, you will be able to vote until the Chairman declares that the voting will be closed.

How do I know that I have voted at the Virtual Meeting?

Can I ask questions as a virtual participant of the Virtual Meeting?

- Yes, questions about items on the agenda can be submitted prior to the Virtual Meeting as described in the convocation. Only shareholders who submitted questions in accordance with the procedures set forth above will be given the opportunity to submit follow-on questions during the meeting for which they will receive separate instructions.

Can I also vote in advance of the Virtual Meeting?



Yes, you can by giving a proxy voting instruction via www.abnamro.com/evoting

I have already voted through proxy on the ABN AMRO Website, do I need to vote again?

No, your proxy voting instruction will remain valid.

I have already voted through proxy on the ABN AMRO Website, can I change my vote during the Virtual Meeting?



If you grant a proxy voting instruction your vote has, in fact, been made before the meeting takes place and you will only be able to change your voting instruction until Close of Registration, Thursday 29 April 2021, at 17:00 CET.

I have already voted through proxy on the ABN AMRO Website, can I still follow the Virtual Meeting?



I am unable to vote.



Once the Chairman has opened the shareholder meeting, you will be able to vote until the Chairman closes the voting, if you are a registered shareholder. Press the voting button **1** to submit your votes. Please make sure you are connected to the internet.

How can I submit a vote?



During the meeting you will be able to vote. Press the voting button **1** to submit your votes. When selecting the button of your choice your vote will be cast automatically. You will see a confirmation in your screen.

How can I change my vote?



You will be able to amend your votes during the meeting, you will be able to vote until the Chairman declares that the voting will be closed.



General questions

I appreciate the possibility to participate online at the Virtual meeting, I wonder how Koninklijke DSM N.V. ensures that online participation will be without issues?



DSM offers the application through third parties that have gathered experience with organizing these virtual meeting. But even though DSM has given its best efforts to ensure that shareholders are offered a best-in-market service, it cannot guarantee that shareholders may experience issues that are common to any first-generation innovative application.

Will all future DSM's AGMs take place virtually?



DSM will at its own discretion, decide on the format of the meeting before each shareholders' meeting.

Why should I choose for online participation when I can grant a proxy voting instruction as I did before?



When you participate online, you will be able to take into account the deliberations (just before and) at the general meeting before you decide how to vote. If you grant a proxy voting instruction your vote has, in fact, been made before the meeting takes place and you will only be able to change your voting instruction until Close of Registration, Thursday 29 April 2021, at 17:00 CET.

What will be done with all my personal data which I am asked to provide when opting for online participation?

Are there any rules and conditions set by DSM that apply to the Virtual Meeting?



Yes, we would like to refer you to the terms and conditions relating to the Virtual General Meeting of Shareholders that apply which can be found on <u>dsm.com</u>. If you participate online, you must read these terms.

I don't have a smartphone, tablet or pc. Will I be able to participate the Virtual meeting?



Unfortunately, in that case the shareholder can't join the AGM virtually.

My internet connection isn't working properly. Will I be able to participate the Virtual meeting?



You will need a working internet connection during the meeting. On your phone you can also use a mobile (3G/4G/5G) signal if available, or use WiFi.

My battery is almost empty. What do I do?



The shareholder is responsible for a properly functioning and charged device.

What are the terms of use?



You can find the policy regarding the Virtual General Meeting of Shareholders on <u>dsm.com</u>. If you participate online, these terms are applicable.

Which device should I use to participate online at the Virtual Meeting?



You can participate at the Virtual Meeting with any device that has a working internet connection and successfully logged in to the virtual environment via www.abnamro.com/evoting. Please make sure to have installed the latest version of your internet browser, Chrome, Firefox, Internet Explorer 11 and 10, Edge or Safari.

The device that I will use for online participation has a camera installed: will, or can, I be made visible in the Virtual Meeting to other participants or anyone else?



When I participate online, will other shareholders be informed that I am participating or do they have the possibility to know that?



No. You will be registered on the registration list of all shareholders attending the Virtual Meeting, in accordance with the provisions of DSM's Articles of Association. However, this information will not be provided to other shareholders of DSM.

exercise of rights

Are my votes valid when leaving early? Can I re-join after I have left?

Yes, assuming you have logged in successfully prior to the start of the Virtual Meeting this will not affect the votes casted until the moment you left. Re-joining the Virtual Meeting after you've left is possible and you will also be able to vote upon items that have been put to vote in the meantime. The polls for all items are open as of the start of the Virtual Meeting. With the exception of the first item regarding the amendment of the Articles of Association, the polls are closed after the last voting item on the agenda has been discussed

When there's a failure in my network connection, or my device stops working during the Virtual Meeting will I be able to login and continue to participate in the Virtual Meeting once the connection has been restored?

Yes, assuming you have logged in successfully prior to the start of the Virtual Meeting, you will be able to continue participating in the Virtual Meeting after the network connection has been restored. You will also be able to vote on items that have been put to vote in the meantime. With the exception of the first item regarding the amendment of the Articles of Association, the polls are open during the Virtual Meeting and closed after the last voting item on the agenda has been discussed.

Will I be able to ask questions or make any comments to the meeting during the Virtual Meeting when I participate online?



Yes, to ask questions, or to comment during the Virtual meeting, you are invited to file questions prior to the AGM. Only shareholders who submitted questions in accordance with the procedures set forth above will be given the opportunity to submit follow-up questions during the meeting for which they will receive separate instructions.





exercise of rights

Are there any voting restrictions when participating online?

 \Rightarrow When participating online split-voting is not possible as it is not supported by the platform yet.

I have registered for online participation, but have sold my shares after that. Can I still vote on these shares?



Yes, according to Dutch law the 28th day before the day of the Virtual Meeting is decisive for who will be able to vote at the Virtual Meeting. As registration is only possible after that record date, 6 April 2021, the right to vote remains even if you have already sold your shares in the meantime.

Will the possibility of online participation affect the proceedings at the general meeting?



At the Virtual Meeting the usual proceedings for general meetings of DSM will be followed. However, with the exception of the first item regarding the amendment of the Articles of Association the polls for all items are open during the Virtual Meeting and closed after the last voting item on the agenda has been discussed.
