For trailers (e.g. trailers, horse trailers, etc.) there is a minimum premium of €27.50 (excl. ass. Tax) per year.

Own risk

For touring Caravans there is a deductible of \in 150,00 per event.

In case of theft of the entire caravan, there is an excess of € 250,00 unless the caravan's chassis number is affixed to the caravan by means of Permanent Mark [®] at least 4 conspicuous places.

For caravans there is an excess of € 45,00 per event. This does not apply in the event of theft of the entire caravan, provided that the chassis number of the caravan is affixed to the caravan by means of Permanent Mark [®] at least 4 conspicuous places.

For mobile homes There is a deductible of € 45,00 per event.

Prevention for touring caravans

If the caravan is left unsupervised, it must be provided with appropriate locks or similar facilities (clutch locks, wheel clamps). If these conditions are not met, damage by theft of the entire caravan is not ensured.

It is therefore important that the caravan is protected against theft. The V.I.P. (Insurers Institute for Prevention) has compiled a list of "V. I. P/T.N.O. approved security products for caravans". You are free in your choice for a prevention tool, but the preference is for "V.I.P./T.N.O." approved wheel clamps and drawbar locks.

Permanent Mark ®

Besides the mechanical security product there is another method to protect the caravan against theft, the marking of the caravan. Replacing and renewing branded parts is complicated and very costly, making the caravan less interesting to "steal".

With Permanent Mark [®], the chassis number of the caravan can be clearly visible and indelibly applied to various parts of the caravan (e.g. windows). You can order the permanent Mark [®] set at an attractive price directly at Permanent Mark [®]. Not only will you receive the "set" but also the corresponding warning stickers.
